at Family Services of NW PA

Family Group Decision Making (FGDM) is a decision-making process that draws on the strength of the family unit to develop a plan to address concerns of child safety, well-being, and overall development.

Getting Started:

FGDM gets involved when a situation occurs that threatens family unity.

An FGDM Coordinator helps the family select people they want to be involved in their conference. This can include:

- Extended family
- Trusted friends
- Community members
- Clergy
- Teachers and school counselors
- Service providers
- Anyone else the family chooses

The FGDM Conference:

A Family Group Decision Making Conference is a facilitated meeting that typically involves immediate and extended family, close friends, other supports and service providers.

Preparing for the Conference:

The FGDM Coordinator will:

- Explain the process
- Help to identify the people to involve
- Invite the individuals to the conference
- Arrange a neutral site for the conference

Why does FGDM Work?

- Family members make the decisions.
- Creates more stable living situations.
- FGDM strengthens relationships between families and service providers.
- FGDM creates a better future for children, families, and the community.

Frequently Asked Questions:

Who should be involved?

Anyone the family wants!

Why have a family conference?

- Parental difficulty in providing for the needs of a child.
- Concerns with child behaviors including truancy.
- Any situation that threatens the ability of a family to remain together.

Is there a cost for FGDM?

No, there is no cost.

Where will the FGDM conference be held?

The FGDM Coordinator will arrange for a community site selected by the family.

How long does the conference last?

Each family is unique. A typical conference lasts between 2-3 hours.

What happens at the Conference?

- Information Sharing
- Family Private Time
- Plan Preservation and Acceptance
- The family plan is put into action
